Melanie Hopkins began her career as a management consultant before moving across to the Civil Service. With the Foreign, Commonwealth and Development Office, she has undertaken postings to Turkey and Cuba, and to the UN, and has also been seconded to the Spanish Ministry of Foreign Affairs. In London, she headed the Australasia section of FCO and, in 2016, was appointed British High Commissioner to Fiji, Tonga, Kiribati, and Tuvalu, and Head of the South Pacific Network - the first female to hold this role. She has two daughters, who have been transformed into 'ocean warriors' following their time in the Pacific. Ms Hopkins completed her tour as High Commissioner in Suva in August 2020.

Zoom Security. We ask all members who are **planning to attend our first virtual AGM** to respond to this e-mail advising their **full names and e-mail addresses**. For **family memberships** wishing to attend, please list everyone who will be viewing from your device. This is important as not all e-mail addresses reflect your given name (first name and surname) and

many devices simply describe themselves as e.g. 'Jill's iPad' or 'Roger's PC' or even simply 'J' or 'Z'. This presents a problem for the Zoom host(s) (who may not know everyone by sight) especially if you choose not to share video, as it's not always easy for the host identify Zoomers when deciding whether or not to admit you via the Zoom Waiting Room. Thank you.

Having said that, I shall, as always (when we meet at in the Penthouse at New Zealand House, which has tight Security) prepare a **'Security List'** of those attending in alphabetical order by surname, which (in normal years) assists our Membership Secretary in chasing up subs for the current year, and which has proved very useful in other Zoom Meetings where a number of participants require admittance in short space of time. **A private link with instructions on how to join the Zoom AGM will be sent in advance of the meeting, to all who have expressed a wish to attend.**

Restriction on Numbers. This year, Council has decided to limit numbers at the AGM to paid-up Members + VIP guests invited by Council, which of course includes the London High Commissions. [This may be reviewed in the light of nos. accepting.]

If you receive this e-mail and you are NOT a member of the Society, you may be a lapsed member, who we feel might like to renew.
